Through the intercession of Mary our Mother, and St. Joseph the Worker, her spouse, we pray that all migrants may be reunited with their loved ones and find the meaningful work they seek. Open our hearts so that we may provide hospitality or all who come in search of refuge. Give us the courage to welcome every stranger as Christ in our midst. We ask this through our Lord Jesus Christ, your Son, who lives and reigns with you and the Holy Spirit, one God forever and ever. Amen (USCCB)

### Action Two: Calls/Letters

**NATIONAL LEVEL** - Call the White House and Department of Homeland Security: **Dept. of Homeland Sec comment line: 202-282-8495 and WH comment line: 202-456-1111**. Tell them you oppose any action to prevent people from seeking asylum and not punish people seeking safety by separating them from their children or detaining them indefinitely.

**NATIONAL LEVEL** - Demand Congress act to repeal the Muslim ban. Sign the petition:
