What's Happening?

Unfortunately, HR 4731 (Refugee Program Integrity Restoration Act of 2016) passed out of committee (18-9) with two additional amendments: 1) By Rep Poe - ORR must give US states 21 day notice for placement of refugees & must provide certification that refugees don't present security threat to that state. If they're not met, Governor can refuse resettlement of a group of refugees or specific refugee. 2) By Rep King - The "people" (of a state) will be able to offer a ballot initiative, referendum, or plebiscite, if the Government does not, to refuse resettling refugees in their state. There is not yet a companion in the Senate. We will continue to monitor & oppose HR 4731 as/if it makes its way to the full House and onto the Senate.

Immigration guidelines permitting deferral of the deportations of millions of people provide "substantial humanitarian benefits" and should be permitted to stand, said an amicus curiae brief, filed March 8 in the US Supreme Court by the USCCB and 24 other US faith-based organizations whose work includes advocating for or providing aid and resources to recent immigrants and their families. The case is *United States v. Texas*, in which some states have challenged the federal government's implementation of immigration guidelines issued by the Secretary of Homeland Security. The guidelines effectively stay the deportation proceedings of 4-5 million undocumented people who pose no national security or public safety threat and who have longstanding close family ties to people in the U.S. These guidelines provide "important benefits to those most vulnerable in our society and to those who serve them" and also ensure "that the public will continue to benefit from the substantial contributions of recent immigrants." By voting on House Resolution 649, Rep. ___ is putting partisan politics over people. The DAPA and DACA+ programs are beneficial to our state and federal government. They would allow for immigrant families to remain united, and provide them with an opportunity to pursue the American dream. It's time for the Representative to put politics aside and stand with hard-working immigrant families! Please vote NO on House Resolution 649!*

Children from El Salvador, Guatemala and Honduras are fleeing traumatizing violence and should not have to stand before an immigration judge alone. *The Fair Day in Court for Kids Act* would increase legal orientation programs, ensure children have access to lawyers, and increase court appearance rates."
