What's Happening?

Last Tuesday, Jan. 19th, the Supreme Court decided to grant certiorari to United States v. Texas, a recent decision from 5th Circuit Court of Appeals that has halted the implementation of President Obama's November 2014 executive actions on immigration. These executive actions would direct officials to exercise discretion, and on a case-by-case basis provide deportation relief for approximately 5 million undocumented immigrants currently living, and working across the U.S. (Adapted from FWD.us)

What can we expect next on DAPA and DACA?

- 1. Briefs of legal arguments will be submitted from both sides, the U.S. Department of Justice (DOJ) and the Attorney General of Texas representing the 26 GOP Governors and Attorneys General who filed against the Administration. These briefs are expected in February.
- 2. In March, groups who support the DACA & DAPA executive actions will submit Amicus (Friend of the Court) briefs.
- 3. In April, the Court will hold oral arguments. Lawyers for the DOJ and State of Texas will each present their case before the Supreme Court.
- 4. In June, it is expected that the Court will issue a decision. For immigrant rights groups to win, the Court must say that Texas and the other states cannot block DAPA and extended DACA.

We must work together to ensure that justice prevails for over 4 million potential beneficiaries of the executive actions.

Last November, the House of Representatives passed H.R. 4038, The American Security against Foreign Enemies (SAFE) Act, which would effectively halt all resettlement of Syrian and Iraqi refugees in the U.S. for a protracted time. On Wednesday, January 20, 2016 the legislation was voted on in the U.S. Senate and it was not accepted.
